Dear Valued Customer,

As part of California's efforts to fight climate change, the California Public Utilities Commission (CPUC) approved the **California Climate Credit** for eligible utility customers. The Climate Credit is a payment to Californians developed as a result of the Global Warming Solutions Act of 2006, which was passed to fight climate change. The Climate Credit results from fees that are charged by the state to help reduce carbon pollution and encourage use of cleaner forms of energy.

Beginning April 1, 2014, Southern California Edison residential customers began receiving the "California Climate Credit" on their bills. The credit will appear as an adjustment on billing statements twice a year during the months of April and October. The semi-annual California Climate Credit amount will be \$29.00 per dwelling unit for residential customers in 2021.

Our bill message reads:

"You Received a California Climate Credit. California is fighting climate change and so can you!  
Your bill includes a Climate Credit from a state program to cut carbon pollution while also reducing your energy costs. Find out how at [EnergyUpgradeCA.org/credit](http://EnergyUpgradeCA.org/credit)."

As a master-metered customer, you are required by state law to pass along any credit or rate reduction that you may receive to your tenants.\*

Please take a moment to check the number of dwelling units SCE has on record for your master meter account. This information can be found on the bill you receive for your master meter. Should the number of units need updating, please call the number below.

Your master meter billing statement will receive a credit of \$29.00 multiplied by the number of dwelling units that SCE has on record for your master meter account. Credits on your master meter bill must be passed on to your tenants. **Each dwelling unit must receive a credit of \$29.00.**

\* California Public Utilities Code Section 739.5 mandates how credits, including the California Climate Credit, should be distributed to your tenants:

(b)(1) Every master-meter customer of a gas corporation or load-serving entity subject to subdivision (a) who, on or after January 1, 1978, receives any rebate from a load-serving entity or gas corporation shall distribute to, or credit to the account of, each current user served by the master-meter customer that portion of the rebate which the amount of gas or electricity, or both, consumed by the user during the last billing period bears to the total amount furnished by the load-serving entity or gas corporation to the master-meter customer during that period.

(2) Paragraph (1) includes the credits stemming from the revenues received by the electrical corporation as a result of the direct allocation of greenhouse gas allowances to electric utilities pursuant to subdivision (b) of Section 95890 of Title 17 of the California Code of Regulations, that are required to be credited to customers of the electrical corporation pursuant to Section 748.5.
